IN 2017, 322 IMPOUNDED ANIMALS WERE RECLAIMED BY THEIR OWNERS. OWNER-SURRENDERED AND UNCLAIMED STRAY ANIMALS ARE PLACED FOR ADOPTION. IN 2017, 1,317 ANIMALS WERE ADOPTED FROM CACHE HUMANE SOCIETY.

OUR ON-SITE CLINIC ALSO INSURES THAT ALL SHELTER ANIMALS ARE SPAYED/NEUTERED AND FULLY VACCINATED PRIOR TO ADOPTION. IN 2018, CACHE HUMANE SOCIETY PERFORMED 2,305 SPAYS/NEUTERS AND PROVIDED OVER 4,500 VACCINATIONS TO COMPANION ANIMALS.
