IN 2018, 203 LOST ANIMALS WERE RECLAIMED BY THEIR OWNERS. OWNER-SURRENDERED AND UNCLAIMED STRAY ANIMALS ARE PLACED FOR ADOPTION. IN 2018, 1,253 ANIMALS WERE ADOPTED FROM CACHE HUMANE SOCIETY.
